## **NOTES TO CONTRIBUTORS & READER**

The Journal of Malaysian and Comparative Law (JMCL) welcomes original unpublished works on topics of legal interest in the form of articles, comments, case notes and reviews.

Each manuscript will be reviewed by the Editorial Board before approval for publication. Contributors will be notified of acceptance, rejection or the need for revision of their respective manuscripts. The Editors retain the right to make stylistic and grammatical changes to manuscripts accepted for publication without necessarily informing the contributor.

### **PREPARATION OF MANUSCRIPTS**

- (1) Manuscripts should be typed on A4 paper, double-spaced, with generous margins on all sides of the paper. A copy of the manuscript should be furnished and, wherever possible, accompanied by a diskette of the manuscript. For those who use e-mail, manuscripts may be sent via e-mail attachments.
- (2) Footnotes should be numbered sequentially from 1 to 99 and should appear at the foot of each page.
- (3) Final responsibility for the accuracy of all citations and quotations rests with the contributors.
- (4) Quotations of more than 30 words should be indented without quotation marks. Shorter quotations within the text should be enclosed by double inverted commas.

(5) The following should be in italics:

- (i) Case names;
- (ii) Latin and other foreign words;
- (iii) Abbreviations - *eg, ie, ibid, cf*; and.
- (iv) Titles of books and law journals/periodicals.

(6) References:

- (i) The full title, date and place of publication should be given at first mention, thereafter, *supra* should be used;
- (ii) Law Reports -
  - (a) MLJ,
  - (b) FMSR,
  - (c) CMLR,
  - (d) All ER;
- (iii) Names of Law journals/periodicals are italicised. Omit full stops from abbreviations -
  - (a) Harvard Law Journal
  - (b) LQR
